What is the Beaufort County Committee of 100?

The Committee of 100 is a non-profit corporation certified as a 501(c)(3) charity by the IRS. Our mission is to improve job opportunities for unemployed and underemployed citizens of Beaufort County. We operate with a Board of Directors but no paid staff. The staff of the Economic Development Commission assists the Committee of 100.

What does the Committee of 100 do?

The Committee of 100 assists the Economic Development Commission in both leadership and financial support. We provide leadership by combining the voices of those who understand and appreciate the benefits that economic development brings. We provide financial support by funding activities that cannot or should not be funded by local government. For example, the Committee has acquired two industrial buildings and leased them to two separate manufacturing companies.

How much are the Annual Dues?

Executive Club Memberships are available on an individual basis (\$100 per year—per person). Various corporate memberships are available for the following annual contributions and include the stated number of (1) one-year memberships for the year the donation is paid.

Beaufort Club Memberships: \$10,000: ten (10) one-year memberships

Pamlico Club Memberships: \$5,000: eight (8) one-year memberships

Coastal Club Memberships: \$2,500: five (5) one-year memberships

Harbour Club Memberships: \$1,000: three (3) one-year memberships

Are There Any Mandatory Meetings?

No. Events such as plant announcements and receptions for visiting industry executives are held on an ad hoc basis. We conduct an annual oyster roast in January, which is free for current members. Luncheon briefings are well attended in Washington, Belhaven and Aurora each month.

What Are the Goals of the Committee of 100?

Beaufort County has experienced unemployment of 8-11 % over the last four years. It is a Tier 1 County, meaning it is in the second-lowest stratum of all North Carolina counties. The Committee's primary goal is to attract manufacturing facilities and large commercial development in order to increase job opportunities in Beaufort County.

How Will That Be Done?

As a nonprofit corporation the Committee of 100 can buy or build manufacturing facilities and lease them to job-providers at very attractive rates. The Committee can also provide funds for purchase options, engineering studies, feasibility studies and other development-encouraging activities.
